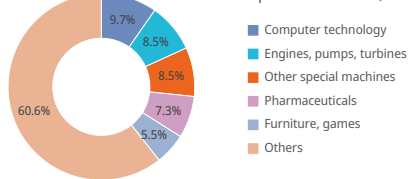

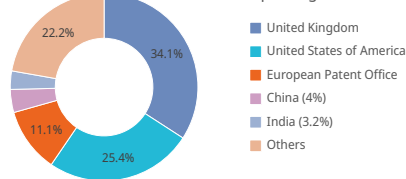

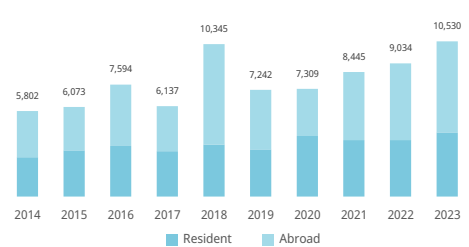

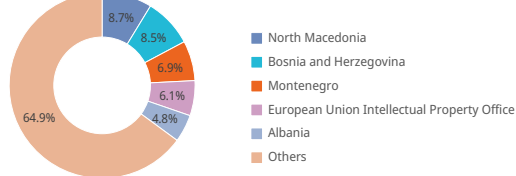
Trademark class count in applications

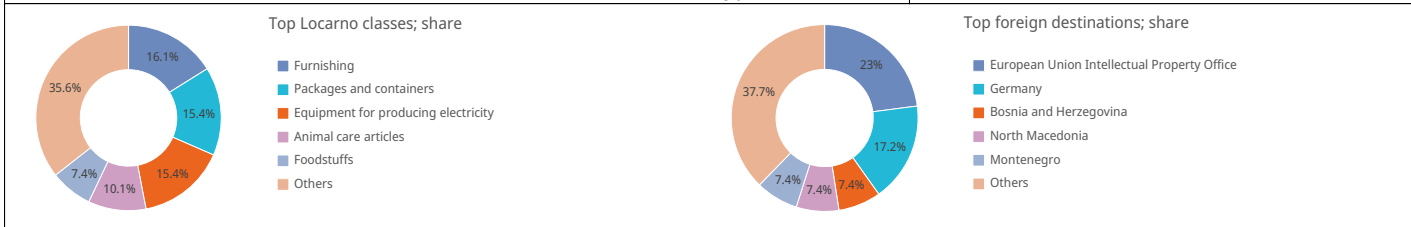
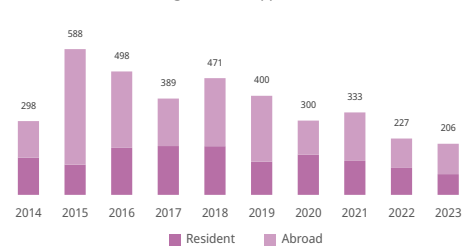
